4a (Code: ) (Expenses \$ 288,535 including grants of \$ ) (Revenue \$ 22,660 ) Education - In 2014, the SFBC Education Fund continued to step up its programs to educate bicyclists about safe riding, as well as reaching out to motorists about safe driving. We continued to grow the city's Safe Routes to School program, working closely with the SF Department of Public Health and other partners, to reach kindergarten and first graders in 92 local schools with the message of safe walking and biking. We also organized and led the city's sixth annual Bike to School Day with approximately 4,000 people participating.

4b (Code: ) (Expenses \$ 288,535 including grants of \$ ) (Revenue \$ ) Workshops - Throughout the year we hosted free Urban Cycling Workshops, teaching 3,000 of adults and children how to be confident, safe and respectful when biking on city streets. These classes, in partnership with the SF Municipal Transportation Agency, help promote safe streets and biking in San Francisco. Through our Adult Learn to Ride classes, we welcomed 100 people to biking for the first time. In 2014, we continued to teach courses for the LGBTQ community, for women, and for Cantonese and Spanish-language speakers.

4c (Code: ) (Expenses \$ 144,268 including grants of \$ ) (Revenue \$ ) Promotion - We expanded our ongoing promotion of bicycling in 2014, making it easier for more people to try bicycling as a safe, affordable, healthy, and convenient way to move around. Our successful outreach events include Bike to Work Day, in which tens of thousands of people try biking, and regular Energizer Stations, in which we recognize and celebrate people who are already biking. We also used donated billboard space in high profile locations around the city and a dedicated new rider section of our Web site to invite people of all backgrounds to "get rolling."
